#### E. Organising Committee:

#### F. Dialog with Members:

The membership of our unit is spread over the state of Maharashtra and Goa. Therefore we have 14 seats in BOI Federation, 6 representatives nominated by Federation on AIBRF and 15 seats in state committee.

#### H. Financial Strength:

Associations' main income is one time life membership fee subscribed initially Rs. 1,250/- per member and Rs. 500/- as per the category. Out of this collection 75% amount is invested in our Bank's Term Deposits. The remaining 25% part of this income and the amount of regular interest on deposits is available for our yearly expenses. It will be coherent to state that the number of retiring staff has come down in these days comparing to last decade as we all know that a large recruitment was in eighties and most of them have now retired.

Our experience is always the expenses are more than income and gap is settled from the general donations received from our members and or from deposits funds. We therefore generally appeal to our members to contribute for general Fund which can meet the gap as specific purpose like Building Fund, Struggle Fund for contributions for legal ae spent for that purpose only.

During CORONA PADEMIC our Federation gave a call to collect fund for Corona victims where 40% will go to Central and 60% of Fund to State Relief Fund. We gave a call and receive good response of members and collected Rs. 479,894/-. Of which 60% Rs. 287,939/- is remitted to State Committee and 40% Rs. 191,958/-remitted to Federation. The State Committee of AIBRF sent the fund to state which was handed over to Chief Minister. Our EC Member Shri. Pramod Desai had taken efforts and through him the state committee got immediate appointment even during strict orders and lock down due to corona pandemic.

After opening of lock down and normalcy in activities established the circular of Family pension improvements was declared at par on RBI and Govt, and was released with arrears. The Federation gave a call and we received spontaneous inquiries from family pensioners and subsequent donations. Experiencing such a response, we appeal for voluntary contribution to our fund and we received an amount of Rs 271,751/- and the 20% of this Rs. 54350/- was remitted to Federation. All these are classic example of gratitude towards the Association. This type of member's confidence encourages the executive committee to move aggressively to achieve the goals of satisfactory service to the members.

Looking back MARCHING ON PROGRESSIVE TRACK STRENGTHING THE FINANCE

#### I. Accounting discipline and Records

Association office bearers are very prompt in accounting of incoming funds and keeping the record as also settling of claims for expenses very fast .The committee members also co-operate and submit the required information bills etc. promptly. The accounts are monthly balanced with regular follow up and the all detailed entries are saved on TALLY. This helps us to finalise the yearly accounts smoothly and efficiently and timely preparation of Balance Sheets. Our Auditors also promptly favour us with their reports and file our returns in time and we receive the refund amount without any delay. Due to the 'CORONA' Pandemic, last two years the time table was disturbed however we are sure that next AGM will be arranged within 3 to 4 months after the Year end.

The membership Register is digitally recorded with all required details and care and efforts were taken by Office Bearers to update the old records of nearly 3000 members. This has helped us mainly to work out any statistical record at a glance. It has also helped our other units for such data, like retiring members, family pensioners. We periodically try to update changes and also appeal in our reports to advise us the change in address and also Mobile numbers and e-mails etc. which are the best and fastest means of communication. The members also get all detailed information promptly and regularly. This is very useful while renewing the yearly Group Medical Policies and also to get assistance during emergencies and help to settle the claims.

We have through meetings, circulars and through tele conversations educated and also helped many of our

members for medical claims and for submission of yearly life certificates.

The management of Digital records and sourcing of data is completed single handed by Shri Rajendra Master. We appreciate the work of sourcing and entering correct data was difficult and tedious job and requires patience. Mr. Master did it with passion and now at any time any information he makes available smoothly and promptly. The messages on whatsapp its data addition deletion is managed single handed by him and his efforts of last 2/3 years has made our records perfect.

#### J. Relationship Bonding:

Our committee is also taking interest in issuing publications periodically on subjects like, Facilities to Retirees, Health related information, write ups on various facilities and improvements thereon like REMAS, Members Directory. Last we have published a very informative booklet for the spouse of the retirees in both languages English and Marathi titled "Effects After" to print in Matathi (Nivruttanchya Nivartananantar) mainly elaborating the procedure, the forms and documents to be submitted, by the claimant after the death of the pensioner . It contains not only information but a special guidance for taking necessary steps for timely submission and achieve maximum benefits. The interested members are requested to contact any of our Executive committee Member for a copy till the stock lasts. We are planning to come out with a directory of 6000+ our members which will enable our members to contact and continue the golden thread relationship amongst all of us.

#### K. Health Management:

The Group Medical Insurance Policy for Retirees was introduced since 2015, this year the policy was renewed from 1st November, 2022. The insurance Company, this year also has given the option to all Retirees who did not exercise the option earlier. Out of total applications 99.36% applied for without domiciliary policy. It is always advisable to opt without Domiciliary policy under the current Rules and regulation. The premium for Domiciliary policy is very high comparing to the benefits of reimbursement. The Retirees group of our Association from Thane & Kalwa arranged a meeting with new TPA, Ericson Insurance TPA at Thane.

The members were advised to attend the meeting with one of the Family Member, there were around 95 participants. The purpose of the meeting was to explain the procedure to be followed at the time of Hospitalisation (Network as well as Non Network Hospitals), how to make hassle free reimbursement claim. This year also the there was a steep rise increase in the renewal premium. Our parent organization, AIBRF has filed memorandum with Chief Labour Commissioner (Central), New Delhi to seek their intervention in resolving the grievances.

This resulted into the Official meeting with I.B.A. for which we were running all places. The minutes of this meeting also received and again we approached the C.L.C. who advised IBA to resolve the matter fully. CLC advised IBA to discuss the issue with our Federation. The minutes of the meeting were placed before CLC who in turn instructed IBA to resolve the matter amicably. We are looking forward for the positive outcome

#### L. Financial Assistance-REMAS:

This is a unique scheme for the welfare of Bank of India Retirees. The scheme was initiated by the contribution from the retirees and allocation from welfare fund. The members of the scheme are eligible for reimbursement either of Hospitalisation Expenses or Insurance Premium (Self Rs.5000/- & Spouse R.5000/- Total Rs.10000/ for Single Rs.5000/-) to the extent of Rs.1.50 Lakhs during the life-time. The amount is directly credited to the pension account of the member availing IBA GMIS policy. Others have to forward the reimbursement application to respective Zonal Office. Before introduction of Insurance Premium reimbursement the members exercised Hospitalisation reimbursement option. Now they could not avail the Premium reimbursement option. Hence we have requested the REMAS Committee for change the option to Reimbursement of Premium for those members. Members who have opted for Hospitalisation will be eligible for reimbursement of Rs.3000/-p.a. in February every year commencing February 2020. The amount will be credited to their Pension account.

#### M. Life Certificate :

All the pensioners have to submit Life Certificate every year in the month of November. The pensioner can submit the application in Physical to their Pension Paying Branch or nearest Branch at their convenience. They can also send the photo or scan copy of duly signed format of Life Certificate to the official email id of the Pension paying Branch (IOM No. HO/TBD/PEN/MW/336 DT.21.10.2022).

Our bank has introduced the free Doorstep Banking Services for submission of Annual Life Certificate & any other 2 free services per month to Pensioners. You may download the DSB App from Play Store or visit www. psballiance.com or call 18001037188/18001213721 for availing the DSB Services (Circular Letter No. 2022-23/ dt.12.10.2022).

Inspite of instruction circulars reminders, the list of retirees, not submitting the life certificates runs in pages. We them for with follow up contacting the retirees over phone try to reach the pensioner and help to reduce the long list.

#### **N. Special Assignment:**

A special assignment was given, by the Federation, to study and suggest measures for improving the procedure for approval of Family Pension and restrict the avoidable delay and also suggestion to simplifying the family pension application forms (which runs for over 6 pages in our Bank).

The Committee appointed for this purpose consist of, Mr. Sharad Hardikar, Mr. Damodar Pagal and Mr. Bhaskar Bhave. All the 3 committee members were selected from our unit. The

Federation has given this opportunity and the members also took it as important task and work seriously. The committee under guidance of Shri S. C. Jain studied the similar applications and procedures up to the final sanction and how to reduce the time lag. The members visited H.R. Departments of few other Banks and discussed with their concerned officials. All the factors were checked even with legal and administrative angle and consolidated Report after deliberations was submitted to Head Office in record time.

The Report was handed over to the Chief General Manager who appreciated efforts put in and promised to look into the same. Head Office is studying the suggestions and considering few of them fully or partially. The Report, it appears, is under active consideration.

#### 3. Federation (FOBOIRA)

The Federation of Bank of India Retirees' Associations (FOBOIRA) is one of the oldest Retiree Organisation working for last 24 Years since 1998 and is successfully assisting about 15000 retirees from 15 Units of 11 states. Our Maharashtra & Goa Unit with membership exceeding 6000, is one of the biggest and strongest unit among the Units of Federation with share of about 40% .We actively take part in the activities and also promptly get the required guidance. Our participation is always appreciated by Federation. Meetings of central committee are arranged to formulate a strategy and all the issues concerning retiree members are discussed in meetings at Head Office with all concerned Officials, to solve the problems. Some issues are settled at the level of Zonal Office also. It is to be mentioned here that we have very cordial relations with these officials and we get cooperation from HR.

#### A. Redresser for Grievances Cell

As per IBA guidelines Bank will set up a cell at Head Office to settle the issues of retirees and hold periodic meetings, at least once in every half year, to discuss major problems across the table, with retirees representatives. Our Bank was the first to formulate such cell at Head Office, H. R. Dept., Mumbai. Our Association discuss various issues with the cell and have successfully attended the majority of problems.

#### B. Meetings with Bank Management at HO

The meetings are scheduled as per IBA guidelines once in half year mostly with General Manager HR and accompanied by DGM / AGM T.B.D. and Heads of section. From the association side 4 officials are attending such meetings. Our members are as per rules of federationare (1) The President, (2) the General Secretary, (3) one designated Organising Secretary, who generally arranges these meetings and the General Secretary of the Unit where the meetings are conducted. Since the meetings are always conducted at Head Office, the Maharashtra and Goa unit gets opportunity to attend this meetings. Currently our Federation President Shri Frederick Martis and General Secretary of Maharashtra unit Shri Sharad Hardikar attend the meetings with the senior management of Head Office . However during the last two years of Corona Pandemic these periodical meetings were obviously could not arranged. It is to be noted that from this year when the activities are normalise the meetings have again started and we are getting now the copy of official minutes, duly approved by the G.M. HR.


We appreciate the steps taken by the Bank management for attending important issues of retirees.

In the meetings at Head Office the major issues are settled agreed and the individual cases were then followed up by the Organising secretary of Federation, Mr. Damodar pagal and the General secretary of Maharashtra and Goa Unit, Mr. Sharad Hardikar in subsequent visits and discussion and follow up with the Department officer.

#### 4. United Efforts for Common Cause at National Front

#### ALL INDIA BANK RETIREES' FEDERATION (AIBRF): :

AIBRF is one of the oldest organisations, registered under Labour Law and one of the largest organisations, a national level apex body of bank retirees. The total membership of AIBRF is approximate 2,60,000 retirees members of 44 affiliate Banks . Our Federation of Bank of India Retirees Associations is affiliated to AIBRF.

The Bank Retirees movement is geared up and moving from strength to strength. Retirees now have grater realisation of the fact that only organised efforts can address the long pending issues.

#### 5. State committee of AIBRF – Maharashtra

AIBRF, with a view to communicate at grass root level members have extended organisational hand as State level body consisting of various regional level representatives of all Banks. State committees are working as extended arm of AIBRF. Our Unit have nominated ten representatives for various posts and they are actively participating. The latest meeting of committee was held on 11th Januay, 2023.

#### Achivements

- Arrears on account of 1616-1684 Index: As per Supreme Court judgement for those, who retired between 1.4.1998 to 30.4.2005, arrears were paid with retrospective effect and interest.
- Second Option of Pension to Compulsorily Retired Employees.
- Notional Benefit of 5-years' Service for Fixation of Basic Pension to Specialist Officers.

- ✤ Intervention in Supreme Court case ion on 100% DA case decision unfavourable
- Group Medical Insurance Scheme for Retirees: improvements.
- On industry level Government and RBI Pensioners get 30% of basic pay as pension as against Bank was getting only 15% which was improved in line with RBI & Government employees i.e. 30% without any limit.

#### Our DEMANDS Updation of Basic Pension.

The basic pension of retirees since 1995 has not revised which is really a concern for senior. In case of Government & RBI retirees, their pension is updated along with revision of salary of working staff.

We are DENADING-Updation at par with RBI Formula and benefits to retirees upto 30-Oct-17, Exercize of 100% D.A.Benifit, before Updation, to retirees before1-Oct-2002, benefits from 1-Mar-2019 as per RBI. Famula, Family Pension also to update.

#### Health insurance

IBA introduced most important facility of health insurance to Retirees. However the premium, initially in 2015 low but subsequently increased manifold, making it unaffordable to retirees against the limited income of monthly pension.

As a welfare activity banks should consider reduction in premium and / or reimbursement of Full/Partial amount of premium

#### **D. Action Programs**

AIBRF during the 5th National Conference at Delhi gave direction for appropriate action at the organisational level to achieve our legitimate demands and to pursue these demands forcefully, in May 2019, prepared a strategy and planned to fight jointly with CBPRO and meeting was arranged with AIBEA and UFBU for their support.

The Agitation initiated by AIBRF, demanding for immediate settlement of the issues were on peak with high intensity and active participation by the bank retirees all over the country. Dharna, Rally, Meetings were held at almost all major cities in the country with large participation by the retirees and support from the MPs, MLAs, Trader, Union leaders and the General Public at large.

Again the campaign of letters to The Prime Minister by e-mails were sent in lakhs by Retirees all corners of country.

Recently the new strategy was experienced and since AIBRF is registered under labor law we took our submission through Central Labor Commissioner (C.L.C.). The office of the CLC have taken up the matter desirously and directed the IBA to hold meeting with representatives of AIBRF and solve the problem.

The AIBRF took up the point that A)? The original scheme approved by Govt. states that the premium of Group Medical policy commonly referred as IBA Policy as yearly renewal where the premium to be same as of the employees and Retirees, but after period of two years the retirees portion was taken separately and as on the basis of Claims Ratio and started increasing year after year and non-affordable for a retiree who wants to live dignified retired life after serving for decades with dedication and commitment for the growth and strength of the financial edifice of the country.

#### However we are very positive and our struggle is continuous till we achieve.

**Comrades,** we have waited enough. As elders we have been throughout pleading and requesting hoping that our sentiments will be well appreciated, respected and accepted. The time has come to give the biggest push ever possible to all our efforts to achieve our reasonable and justified demands.

We call upon our Comrades to participate in all Action Programs in full strength and with firm determination and March Forward and make the struggle a thundering **SUCCESS**

"Ex-gratia amount payable to Pre-1986 retirees and spouses has been increased to a minimum of Rs. 10,000/- p.m."

The benefit will accrue to the eligible retirees / spouses immediately.
